**Continuous Assessment process in 2022-23**

Based on the appropriate process and approval of the appropriate authority, the process of continuous assessment in the academic year 2022-23 would be as per following.

All round development of a student is the prime motive of the University through the academic contents and other activities. Skill of presentation, group discussion, quiz and report writing are some of the major skill need to be focused. In order to practice such skills during learning courses of the curriculum, the process of continuous assessment (CA) could be designed in such a way so that skill of presentation and report writing is achieved in a systematic way. The continuous assessment for the students of the University would be conducted in the following manner:

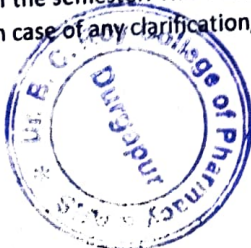
**Continuous Assessment 1 (CA1):** CA1 would be based on presentation, Quiz, Group Discussion etc skill of a student. Faculties would advice students to make ppt presentation based on the some contents/assignments of the courses taught in the semester and also assess students on Quiz, Group Discussion etc. During setting the strategies of content/topics of presentation, components of outcome based education (OBE) and Bloom's Level (BL) of taxonomy should be considered. Appropriate assessment rubrics to be developed and followed during this evaluation. The pdf version of the presentation would be uploaded in the University portal during submission of marks of the CA1. This would help students to enhance their presentation, group activity etc skills.

**Continuous Assessment 2 (CA2):** CA2 would be based on report writing skill of a student. Faculties would advice students to submit report based on the contents/exercise and assignments of the courses taught in the semester. During setting the strategies of content/topics of presentation, components of outcome based education (OBE) and Bloom's Level (BL) of taxonomy should be considered. Appropriate assessment rubrics to be developed and followed during this evaluation. The pdf version of the report would be uploaded in the University portal during submission of marks of the CA2. This would help students to enhance their report writing skill.

**Continuous Assessment 3 (CA3):** CA3 would be based on class test in pen and paper mode. The process of CA4 of the last semester would be followed in this matter. After the internal examinations conducted at college level, the scripts are to be uploaded in the University portal and assessment to be done online in the University portal. Marks would be automatically transferred to the CA3 panel. During setting the question papers, appropriate strategies of OBE and BL to be followed. This would help students to enhance their offline examination skill.

**Continuous Assessment 4 (CA4):** CA4 would be based on centralized online test to be arranged by the University. The process of online examinations used in the end semester examinations in last academic year would be followed. Students would appear on online MCQ based questions in the proctored environment. The CA4 would be based on the entire syllabus of the curriculum and would be conducted at the completion of the semester. This would help students to enhance their online examinations skill.

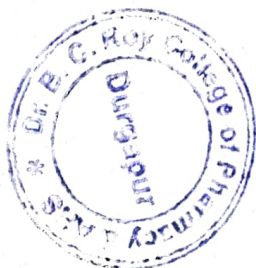

**Assessment of CA 3 of Odd Semester 2022-23 in central DVS system of University**

University has developed one central digital assessment facility for affiliating colleges to maintain assessment databases in a systematic manner in order to take quality measures in delivery of academics and assessment process. The facility is available through one mobile application viz. 'UCanEvaluate' (to scan and upload documents) and one online digital evaluation system (DVS) portal solution (to evaluate uploaded answer scripts).

The following would be the steps for the central CA3 evaluation during odd semester 2022-23.

- 1. Preparation of question papers:** Continuous Assessments (CAs) are conducted through different methods to ensure development of different skills among the students to test different levels of Bloom's Taxonomy and other components of OBE as per notification of the University in this regard. The CA3 would be a pen and paper offline examination. There would be 5 numbers of 1 mark question (maximum questions could be upto 7 out of which 5 need to be answered) and 4 numbers of 5 marks question (maximum questions could be upto 6 out of which 4 need to be answered) to make it a 25 marks assessment. Giving alternative questions (i.e. more than five 1 mark questions and more than four 5 marks questions) would be the policy decision of individual colleges/teachers.
- 2. Conduction of Examinations:** The examinations would be held at the college level as usual based on the schedule and strategies of the individual colleges. However, the schedule should be planned in such a way that evaluation in the University DVS portal could be completed within 20<sup>th</sup> October 2022.  
The examinations would be preferably conducted in A4 size paper or scripts normally used by the colleges. All the pages used by the students to answer the questions need to be uploaded (there would not be compulsorily 8 pages uploading in this semester). In order to maintain transparency, number of pages uploaded (only number of pages, not the scanned pages) against each students would be made available to the student's login, so that any dispute regarding number of pages used by the students is resolved before completion of evaluation.
- 3. Uploading answer scripts in DVS using mobile app:** After the examinations are held, the answer scripts need to be uploaded using the mobile app viz. 'UCanEvaluate' available in Google play store. Login credentials of all the faculties who are tagged with the theory courses would be similar with that of the university examinations portal. After logging in, the list of enrolled students with their details against each of the courses tagged against one teacher would be available in the mobile app. On clicking the name/ roll number of a student against a course, the scanning screen would be opened with the facility to scan and upload

answer scripts (including front page). Only the pages used by the students of the CA3 answer scripts need to be scanned uploaded (blank pages need not to be uploaded). There would be provision to re-upload the scripts in case of any improper upload.

Apart from uploading facility through the mobile app, scanned scripts could also be uploaded in examinations portal through the teacher's login/ college login, in case they are scanned through some other scanning devise.


- 4. Evaluation in DVS system:** Once the answer scripts are uploaded through the mobile app/ uploading through examination portal, they would be available in the tagged teacher's login in the examination portal. However, before starting evaluation in the DVS, pdf form of the question paper, model answer and assessment rubrics need to be uploaded in the DVS system through the link available in the teacher's login/mobile app. The answer scripts now could be evacuated in DVS and marks entry panel would be available as per format of question papers explained above. Evaluators need to evaluate all the answers given by the students (including excess answers in case of alternatives available in the question paper) and the system would take care to consider the maximum marks possible against one answer script. Before final submission of one the scripts after evacuation, the synopsis of evaluation would be available. The complete details of evaluation would also be available to download in teacher's login. Once all the scripts are evaluated, the marks would be automatically transferred to the CA3 submission portal and teachers need not re-upload the marks in CA3 submission portal. The evacuated scripts which would not be available against the enrolled students would be considered absent for CA3.
- 5. Sharing of assessment data:** After the evaluation is over, the complete details of evaluation data including marks against each question would be made available in individual teacher's login and the complete list in the college login. The micro data would help the colleges to calculate attainment and implement OBE at college level. The pdf copy all evaluated answer scripts with annotations would be made available to the colleges in soft form from the office of the Controller of Examinations on demand.

The process would be made open for all teachers from 12<sup>th</sup> September 2022 and would remain open till 17<sup>th</sup> October 2022 for uploading of answer scripts and other documents and till 20<sup>th</sup> October 2022 for completion of evaluation in the DVS portal. The schedule of examinations of CA3 may be planned by the individual colleges accordingly.

One manual for the entire process would be made available for ease of the teachers and colleges. Helpline would also be available for support.

### NOTIFICATION

#### Odd Sem End Semester Examinations 2022-23 - procedure

This is for information of all concerned that appropriate authority of the University has decided the following in respect of Odd Semester End Semester Examinations 2022-23:

#### **1. Mode of end semester examinations:**

It is decided that end semester examinations would be conducted in offline mode in 32 page answer scripts specially designed for digital evaluation purpose.

The practical and sessional examinations would be held at respective college as per earlier practice.

#### **2. Final question pattern for end semester examinations:**

The question pattern would be of (i) 10 out of 12 of 1 mark each very short answer/MCQ etc, (ii) 3 out of 5 of 5 marks each of short answer type (iii) 3 out of 5 of 15 marks each of long answer type totaling 70 marks as per original format.

#### **3. Question paper delivery to the colleges:**

It is decided that question papers would be delivered to the colleges as protected digital version of question papers through the examination portal on the day before the examinations and the password would be made available on the day of examinations.

#### **4. Printing facility in the colleges:**

The process of delivery of question papers in digital mode has already been piloted in PG programs in last offline examinations. The matter of developing printing facility for this session has already been informed to the colleges through workshops conducted physically in different parts of the state in last semester. Colleges would ensure printing facility of the question papers accordingly. The printing cost would be reimbursed to the colleges @Rs 1.00 per page.

#### **5. End Semester Practical Examinations process:**

The practical and sessional examinations would be held at the college level during the time specified by the University. The examiners for practical examinations would be engaged by the head of the institution of the respective colleges. However in case of exceptional cases University may deploy monitoring process /engage external examiners as per requirement for quality purpose.

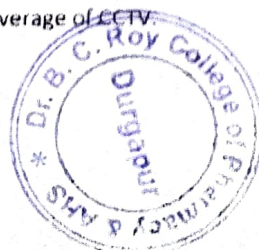
#### **6. End Semester Theory Examinations process:**

All theory examinations would be held at the respective colleges. University examination portal will facilitate to generate seat arrangement, online attendance submission, top sheet generation etc for conduction of examinations. Despatch of answer scripts packets and collection in central hub would be tracked through mobile app developed for this purpose.

#### **7. Monitoring of examination halls of the colleges through CCTV:**

It is decided that examination halls of the colleges would be covered with CCTV and would be monitored from the central control room of the University. Most of the colleges already had installed CCTV during last offline examinations and was monitored from University successfully. The matter of installation of CCTV was again appraised during the workshops with the colleges in last semester.

The control room from where question papers would be printed and answer scripts would be packed also need to be under coverage of CCTV.

## 8. Engagement supervisors during examination days:

It is decided that University would send external resources to the examination centers who would supervise and monitor the digital facilities and examination process during end semester examinations.

University may engage special roaming team for surprise visit as per requirement. Zonal centers of the University may be utilized for organizing such purpose.

## 9. Assessment of answer scripts of the end semester examinations:

All used answer scripts after examinations would be taken to central hub at University in duly sealed packets for the purpose of scanning the scripts. Scope of using zonal scanning centers would also be explored. After scanning, the scripts would be uploaded in the digital evaluation portal for evaluation by the examiners in distributed mode. Examiners would be engaged from the pool of faculties in the affiliated colleges. It will be mandatory to participate in the assessment process by the examiners of the affiliated colleges.

## 10. Examinations of 1<sup>st</sup> Semester and 3<sup>rd</sup> Semester (programs with lateral entry scheme):

It is fact that admission process of lateral entry students are not over till date and registration process of all such students are not completed till date. Conduction of examinations for such students without registration in the University and enrollment in the semester is not possible.

It is therefore decided that all end semester examinations of all such 3<sup>rd</sup> semester programs where lateral entry scheme is applicable (Like B Tech, B Pharm, B Arch etc) the examinations would be conducted in February 2023 along with the 1<sup>st</sup> semester examinations.

All other examinations of 3<sup>rd</sup> semester would be held in the month of December 2022 along with examinations of 5<sup>th</sup> and 7<sup>th</sup> semester.

## 11. Truncated Academic Schedule for 1<sup>st</sup> Sem and 3<sup>rd</sup> Sem (programs with lateral entry scheme):

The end semester examinations would be conducted in the month of February so as to complete all examinations within 15<sup>th</sup> February 2023 and to commence classes of all 2<sup>nd</sup> semesters from 16<sup>th</sup> February 2023 onwards.

There would be 3 CAs for all 1<sup>st</sup> semester and programs with and lateral entry schemes (CA2, CA3 and CA4). In case of delay of registration and enrollment process, colleges would be advised to complete CAs as per calendar below and upload all records in the University portal as and when the enrollment process is completed and provision is created.

**CA2/PCA1 to be completed during 23.11.22 to 26.11.22**

**CA3 to be completed during 21.12.22 to 24.12.22**

**CA4/PCA2 to be completed during 17.01.23 to 21.01.23**

End semester examinations for all 2<sup>nd</sup> and 4<sup>th</sup> semesters would be conducted with all other even semesters in the month of June 2023 as per University academic calendar.

## Notice on Form fill-up for Regular & Backlog Students for Odd Semester Examinations 2022-23

Competent authority of the University has decided to conduct end semester (odd) examinations 2022-23 in offline mode as per notifications published earlier for 3<sup>rd</sup> (except B Tech and B Pharm), 5<sup>th</sup>, 7<sup>th</sup> & 9<sup>th</sup> semester regular and backlog students and all concerned are advised to follow the steps for application /form fill-up for the same as per following.

1. Application form would be available in college login for all enrolled of 3<sup>rd</sup> (except B Tech and B Pharm), 5<sup>th</sup>, 7<sup>th</sup> & 9<sup>th</sup> semester regular and backlog students of UG and PG program for issuance to the eligible students.
2. On release of the online forms by the colleges concerned, students can submit the application online from their login. In case, there is problem of connectivity, college admin can submit the application on the basis of request from the student.
3. Upon submission of the forms, the students will be able to submit their examination fees online through different methods available. In case of non-availability of online payment facility with the students, provision would be available to pay the fees of the students by the colleges as earlier.
4. The regular and backlog form have to be filled up separately by the students.
5. After payment of the fee(s) student must download the form for future reference.
