# Policy Document for Award of Institution/ Non-government Scholarships and Freeships

Scholarships and freeships are awarded to students not only by our educational institution but also by government and non-government agencies.

The policy for awarding institution/ non-government scholarships and freeships is as follows

1) West Bengal Freeship Scheme (WBFS): In this scheme, under graduate students get the facility of waiving off half of their tuition fee-

i) if they are admitted through West Bengal Joint Entrance Examinations Board (WBJEEB)/ Joint Entrance Examination MAIN (JEE MAIN) counseling and their family income is less than 2.50 lakhs per annum.

ii) students get the facility of waiving off full of their tuition fee one each against number of students admitted in management quota if they are admitted through WBJEEB counseling and their family income is less than 2.50 lakhs per annum.

Purpose:

To encourage the economically weaker students to continue their study.

#### Procedure:

The applications are invited from the higher education department, govt. of west Bengal through the institution and then the applications are first submitted by the students in the particular web portal of Higher Education Department (www.wbhed.gov.in/wbfs) and the applications come in the institute portal of that scholarship. The institution verify the applications and forward them to the Higher Education Department, Govt. of West Bengal for approval and only those applications get the approval which had been selected by The Higher Education Department, Govt. of West Bengal. Waiving off the tuition fee of the approved candidate is from the semester mentioned by Higher Education Department till the end of their course. The name list of the approved students is published in web-portal of Higher Education department.

Maximum 10% of total sanctioned intake can be approved for this scheme.

Eligibility:

a) Upper limit of annual family income should not be more than 2.50 lakhs per annum.

b) Student must have Merit Rank in State or Central Level Entrance Examination.

c) Student should take admission under Tuition Fee Waiver (TFW) category and student ávailing Swami Vivekananda Merit Cum Means Scholarship of Govt. of West Bengal cannot apply for this scholarship.

Once the students once get approval, they pay only half of their tuition fee or do Samirkunas Semantahe end of their course, but other fees are paid by them (beneficiary)

2) Tuition Fee Waiver Scheme (TFW): In this scheme, students get the facility of waiving off their full tuition fee. This scheme is applicable to all approved Technical Institutions offering bachelor program. Seats upto maximum 5% of sanctioned intake per course shall be available for this admission. These seats are supernumerary in nature. These seats are available only in state level entrance examination (WBJEE).

Purpose:

To encourage the economically weaker but meritorious students to continue their study.

Procedure:

The competent authority for this admission is West Bengal Joint Entrance Examination Board. In the state level entrance examination a separate merit list is generated and admission is done on the basis of the merit list generated.

Eligibility:

- a) Annual family income should be below 2.50 lakhs to be eligible for seats under this scheme.
- b) Candidate must have a TFW rank in WBJEE.
- This scheme is mandatory for all institutions.
- Under this scheme only the tuition fee is waived off, all other fees are paid by the beneficiary.
- In the event of non availability of the students in this category, the seats cannot be offered to any other category of applicants.
- Since total of the tuition fee is waived, it should be considered as freeship offered to the students.
- 3) M.Pharm Scholarship Scheme: This scholarship is given by the Management of Dr. B. C. Roy College of Pharmacy and Allied Health Sciences (BCRCP), Durgapur to every student studying Post Graduate (M.Pharm) at BCRCP.

To encourage active participation of the students throughout their course.

Procedure:

The approving authority is the Management of the college. Every student irrespective of their merit and means get the scholarship of Rs. 3000/- from the month of admission to the end of the course. Students list approved by Head of the Institution goes to the management on a regular interval for final approval of the students to get the scholarship.

4) Scholarship from Students Welfare Committee (SWC) of the University (MAKAUT): This scholarship is a scheme of University and is given by the college in collaboration with the University(MAKAUT)

### Purpose:

It has been observed over the years that due to the demise of the earning member of the family or incapacitance of the student himself / herself, they discontinue their study. This scholarship is given as a financial assistance to such casualty stricken students.

#### Procedure:

The above mentioned students apply to the University authority through the college. Approved name list of the students is published in the University website by mentioning the starting semester for waiver. Once approved, the students get this facility till the end of their course.

### Eligibility:

This scheme is applicable to the students who face hardship during their course of study in the particular institution due to a) Death of parent/ guardian/ earning member of the family b) accident faced by the student during their studentship.

- In case of death of parent/ guardian/ earning member of the family, 100% of semester fee is waived (50% of semester fee is waived by the respective college and 50% is provided by the University) till the end of their course.
- In case of accident faced by the students during their studentship, 1/3<sup>rd</sup> of total expenditure or Rs.1.00.000/- (whichever is less) is waived. This sort of facility is extended during the entire tenure of the studentship of any student.
- 5) IPA Bengal Pharma Healthcare Trust Scholarship: This scholarship is given only to the students who are studying Pharmacy, B.Pharm (Degree course) or D.Pharm (Diploma course).

Purpose:

To encourage the students to study Pharmacy course and thereafter to be engaged as Pharmacy professionals.

Procedure:

The student applications are forwarded by the institution to the IPA Bengal Pharma Healthcare Trust authority. One time grant of Rs. 5000/- is awarded to the selected student.

Students of D.Pharm 2<sup>nd</sup> year and B.Pharm 2<sup>nd</sup> year to 4<sup>th</sup> year can apply for this scholarship.

Anstitution and students are informed about the selected candidates through a letter from Bengal Pharma Healthcare Trust and on a particular date a cheque of Rs. 5000/- ar

6) Sitaram Jindal Scholarship Scheme: The Sitaram Jindal Foundation is a charitable organization in Bangalore which gives scholarship to the needy meritorious students of different courses. The students of D.Pharm, B.Pharm or M.Pharm can apply for the scholarship.

To encourage the needy meritorious students to continue their study.

Hard copy of blank application forms are downloaded from website and is filled up by the student and forwarded by the authority of the college. The hardcopy of this forwarded application is sent to the address mentioned in the website. Once the application is approved, a cheque of the particular amount is received on semester basis, and then student need not renew the application in his/her next semester/ year of study.

The scholarship authority sends a letter to the student for submitting his/her mark sheet of that particular semester and receipt of cheque received by the student in presence of Head of the Institution. After receiving the documents they send his/her next installment.

#### Eligibility:

All the students of B.Pharm, D.Pharm and M.Pharm can apply for this scholarship if income criteria is matched. Fresh applications are not accepted from final year B. Pharm students

- Income certificates issued by the competent authorities mentioned in their website (www.sitaramjindalfoundation.org) are accepted. A student should apply for scholarship only once in the duration of the course. Scholarships are given to all govt., govt. aided or private institutes where exorbitant fee is not charged from the students.. Scholarship shall be discontinued if the student crosses 30 years of age, or start receiving any other financial assistance.
- The amount of Scholarship per month is Rs. 1800/- (Rs. 3000/- for hostelers).

• The eligibility marks percentage of the student for D.Pharm is 55% and for B.Pharm and

M.Pharm is 65%.
