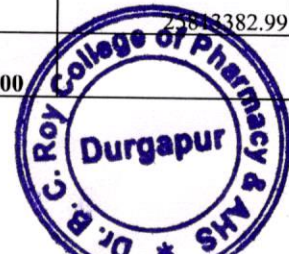

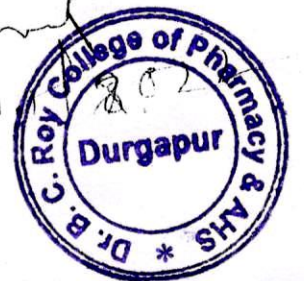

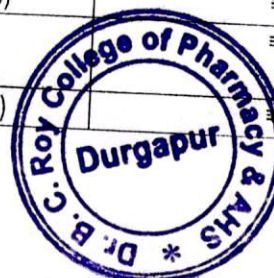
After a brief discussion, members unanimously accepted the lists.
