General Conditions 2.

Network Availability-Fault Management

It is technically impractical to provide a fault free service and SANHATI INFOCOM SERVICES 2.1 PRIVATE LIMITED does not undertake to do so. Assuring the uptime service up to 99 % & down time shall be calculated annual wise.

Packet Delivery Ratio is defined as the average ratio of packets, which are successfully delivered over the Service Provider's network in a given period within the Committed Information Rate (hereinafter referred to as CIR).

Mean time to repair is defined as the average time to restore service during a Network Outage.

Scheduled Maintenance Scope: 2.4

Scheduled Maintenance shall mean any maintenance at the Sanhati PoP to which CUSTOMER's circuit is connected in respect of which CUSTOMER shall be notified 8 hours in advance. Notice of schedule maintenance will be provided to CUSTOMER's designated point of contact by a method elected by SANHATI INFOCOM SERVICES PRIVATE LIMITED (through telephone or email).

Exclusions 2.5

The following faults or outage hours shall be excluded:

- Periods where services have been restored by other alternate means.
- Periods where CUSTOMER staff is inaccessible to confirm the service condition after fault Periods where any link is switched off by CUSTOMER for its own reasons. It is the onus of
- CUSTOMER to ensure that the onsite equipment for links are powered on and/or the network monitoring tools, if any that are used by the CUSTOMER filters out the time period of link being . voluntarily switched off, from the downtime calculations.

- A downtime is considered if the link is down for more than 15 minutes after the CUSTOMER has Failure or malfunction of any CUSTOMER equipment's for which the CUSTOMER is operationally been issued a complaint.
- Interruption during any period when the CUSTOMER elects not to release the service for testing or
- repair and continues to use the Service on an impaired basis. CUSTOMER usage of bandwidth in excess of committed bandwidth Virus attack from CUSTOMER's network on SANHATI INFOCOM SERVICES PRIVATE LIMITED, forcing


