After the 27th BOG meeting, there had been some developments in the College, which the Member Secretary informed the Hon'ble members through his report.

- The College had successfully applied for EoA 2019-20 at the AICTE portal within the stipulated time frame with no deficiency. The college was waiting for the EoA, which was expected by April-May 2019, MS apprised the hon'ble members.
- The Member Secretary reported that this year onwards the PCI had changed the hard copybased SIF submission to Online system in line with the AICTE and informed the members that the Composite SIF for B. Pharm. and M. Pharm. courses and Annual Affiliation fee for AY 2019-20 had been successfully submitted within due time. He thought pertinent to mention here that the college already had PCI approval up to AY 2021-22.
- The college had successfully submitted the NBA SAR (Self Appraisal Report) as per the latest format provided by NBA on 7th March 2019. The college had proposed the earliest date for visit as 23rd April 2019 and latest date as 10th May 2019. However, the NBA had not yet confirmed the visit dates, reported MS.
- The Member Secretary apprised the Hon'ble Members that with the extensive support from the Management, Staff, Faculty, Students and Sponsors, the International Conference BCRCPiCON-2019 held on 4th and 5th February 2019 had been a grand success. A total of 776 delegates of 29 colleges from West Bengal and outside joined the conference. The detailed report of the conference was attached with the brief notes of the BOG meeting as Annexure I.
- The MS informed the Hon'ble members that this year 11 of final year UG students had qualified for GPAT 2019 with highest All India rank 116 (Mr. Surajit Kumar Saha) and 2 of B. Pharm IV year students have qualified for GATE 2019 with one student, Mr. Subir Chatterjee had secured AIR of 32 in the paper "Life Sciences". The MS also informed that like previous years this year too 2 students namely Ms. Anupama Banerjee of B. Pharm. Final Year and Mr. Sujoy Thakur of B. Pharm. 2nd Year had been granted prestigious scholarship of Rupees five thousand each from IPA Bengal Pharma and Healthcare Trust by competing with other colleges.
- The Member Secretary informed the Hon'ble members that the college had started a Medical Unit and thanked the management for signing MoU with The Mission Hospital to provide the facility.
- As per the requirement of EoA 2019-20 from AICTE, the MS informed the members that the college had signed MoUs with 5 (five) industries/hospital to provide industrial/clinical training and to collaborate in research. In this context, he also reported the members that the Director and Prof. (Dr.) Suman Roy alongwith Ms. Olipriya Roy of CU were engaged in a collaborative research work with The Mission Hospital, Durgapur in the field of antimicrobial resistance and its mitigation, which was yielding promising results.
- The MS apprised the members that the college had been granted the Trade License for the Pradhan Mantri Bhartiya Janaushadhi Kendra at the campus by DMC. The Application fee for 5 year Drug License had also been deposited and the college was in constant touch with the local Drugs Control Office at Burdwan to expedite the process. The PMBJK was

Approved by AICTE & PCI and Affiliated to West Bengal University of Technology expected to start functioning by mid-Mayegtman Saha-Sarani Bidhannagar Durgapur-713206, West Bengal was supposed to provide a onetime financial assistance of ₹2,50,000/- in installments for opening the Pharmacy.

Finally, there had been several co- and extra-curricular activities taking place in the college like every year. The college celebrated International Mother Language Day (on 21st February 2019), Basanto Utsav (on 20th March 2019) and Technical Fest (ZENTECH 2K19 on 29th & 30th February 2019). Along with the technical fest, in collaboration with Durgapur Viswagandha Society (an NGO), the college organized a National Seminar on "Current Research in Medicinal Plants - Global Trends and Indian Scenario" on 28th and 29th March 2019, wherein 180 participants from the college and outside attended, with 20 odd farmers attending the seminar to learn from experts regarding cultivation and marketing of medicinal crops. Several experts including Chief Conservator of Forest (WB), Mr. J. T. Mathews, IFS attended and deliberated in the seminar. On 27th March 2019 an educational Visit to Amlachati Herbal Garden was organized for B. Pharm. 3rd Year students. About 100 students participated in the day long tour. On 6th April 2019, on the occasion of World Health Day the college had organized a voluntary blood donation camp in association with The Mission Hospital, Durgapur where 68 students and faculty donated blood. A lecture seminar on "Application Potential of Plant Bio-molecules and Development of Unique Tumoricidal Molecule" was also organized. Former Senior Principal Scientist, IICB, Dr. Samir Kumar Dutta deliberated on the topic in presence of 150 students and faculty members. Dr. Asamanjo Chattaraj, Associate Prof. & Head, Dept. of Animal Science, Kazi Nazrul University, Asansol delivered a seminar lecture on "Artificial Light at Night (ALAN) and Chronodisruption in Ovarian Physiology: Role of Melatonin, the Chonobiotic Molecule" on 02-03-2019, reported the MS.
