Discussion and Resolution:

Chairman, BOG suggested continuing the persuasion with the President of the PCI through CC and EC members of the PCI. He also told that the alumni activities are to be highlighted in all dimensions.

Dr. Satyajit Bose proposed that the sum of "Best Student Research Article" award should be increased.

The members expressed their satisfaction over the Action Taken Report.

35.03Report of the Member Secretary on Progress of College & Academic Activities:

The Member Secretary put forward a warm welcome to all the Hon'ble Members of the BOG to the 35thmeeting of the board. As Member Secretary of the BOG, he apprised on the progress &activities of the college after the previous BOG held on 25thJune 2022.

- With great pleasure, the MS informed the Hon'ble Board members that subsequent to NAAC peer team visit to the college on 18th and 19th August 2022, the college had been accredited by NAAC with CGPA of 2.82 on 4 point scale with a B++ grade and a validity up to August 22, 2027 (for 5 years). A report on the visit was placed under agenda 35.04.
- The Member Secretary reported that the NBA validity was up to 30-06-2023 and as per the norms, the college had applied for reaccreditation to National Board of Accreditation on 24th Dec 2022 (i.e., at least six months prior to expiry of validity) in the format specified by the Board. Subsequently, the NBA authorities had communicated 25th Feb 2023 as the date of visit for reaccreditation.
- The MS informed the Hon'ble members that the college had received extension of approval from both AICTE and PCI, and the affiliations from MAKAUT, WB and WBSCT&VE&SD were also received from respective authorities for AY 2022-23 with 60 intake for D. Pharm, 100 intake for B. Pharm and 15 intake each for two PG programmes. From that AY, the college also received approval and affiliation for two new PG programmes, namely, M. Pharm (Pharmaceutical Analysis) and M. Pharm (Industrial Pharmacy) with 15 and 9 seats respectively. Hence, the total approved intake at 1st year for the college stood at 214 across all programmes.
- The PCI renewal portal had opened on 5th Feb 2023 and the college had already submitted the application (including application for raise in admission of M. Pharm Industrial Pharmacy from 09 to 15 intake) and paid the requisite fee of Rs. 8.85 lakhs online (as per the revised PERC) on 16th Feb 2023. Reported the MS.

• As per the directives of the GoWB, the college had submitted the requisite structure data to "Banglar Uchhashiksha Portal" for all current students of the college.

- Regarding the admission scenario, the Member Secretary informed the members that for AY 2022-23, the college had achieved almost full admission for all the courses (i.e., D. Pharm-60/60, B. Pharm - 104/105, B. Pharm lateral - 13/13 and M. Pharm -52/54).
- Between the 34th and 35th BOG, the college had conducted 03 offline and 01 online
 - A seminar on "Development of Novel Research Methodologies for better understanding of Neurodegenerative Diseases" was delivered by Dr. Debjani Roy, Asst. Prof., Dept. of Biophysics, Bose Institute, Kolkata with 81 participants at APC Roy Seminar Hall of the college on 20-09-2022.
 - An invited talk on "Research and Development Methodology of Formulation in Generic Company" was delivered by Mr. Sayan Chatterjee; our Ex-student and Senior Manager, PMD, Cipla Ltd., on 09-11-2022, where 66 participants.
 - On 11-11-2022, Prof. Upendra Nagaich, HOD, Institute of Pharmacy, Amity University, Greater Noida and Editor-in-Chief, Journal of Advanced Pharmaceutical Technology & Research (A product of Wolters Kluwer Health, Philadelphia, USA) delivered a lecture on "Patent: A Priceless Element for Intellectuality" in the Seminar organized by IQAC, BCRCP wherein 144 UG and PG students and faculty were the participants.
 - A webinar on "Interview Techniques for the Freshers' and Resume Writing" was organized on 07-01-2023 in association with CLINI INDIA during which Ms. Nikita Jogewar, Head of Business Development & Corporate Training, Clini India enlightened the student participants on the techniques of Resume writing and measures required before facing an interview.
- The in campus/ offline classes were continued, post COVID and the details are in MS reports. Meanwhile, the end semester examination for the UG and PGeven semester 2021-22, was completed in online mode during June-July 2022. Subsequently, the odd semester 2022-23 examinations in offline mode for UG 3rd and 4th year were completed in December 2022 and for D. Pharm Part I and II during July-Sep 2022. The UG 1st and 2nd year and PG 1st year Odd Semester examinations were held up to 13th Feb 2023. From the Odd Semester 2022-23 onwards, MAKAUT, WB had stipulated four CAs in the form of Presentation/Quiz (CA1), Report Writing (CA2), Pen & Paper examination (CA3) and University conducted online MCQ based examination (CA4). The results of UG and PG even semester 2021-22 and D. Pharm Part I &II were out and were presented under agenda 35.06.
- The placement season for AY 2021-22 had ended and that for AY 2022-23 had begun, reported the Member Secretary. For AY 2021-22, out of total 205 students of Diploma, UG and PG Pharmacy courses, students had secured 124 jobs and 56 students had opted for higher studies (B. Pharm/M. Pharm/Ph.D). The details were tabled under agenda 35.07.

35.04 Status Report on NAAC Peer Team Visit

The NAAC peer team (PT) visited BCRCP campus on 18th and 19th August 2022. The peer team consisted of Prof. Pramod Yeole (Chairperson), Dr. Preeti K. Suresh (Member Coordinator) and Dr. D. Swarnalatha (Member). The visit went on well in a cordial environment and the PT members were mostly satisfied with the documentation and infrastructure of the college. The team painstakingly went through the infrastructure of the college and documentation for Criteria 1 – 4 on the first day of visit, and recommended certain measures (such as improvement in the Fume Cupboards of some of the labs) verbally and a few written ones in their report. On the second day, there was limited time, though the team went through Criteria 4 – 7, and finally they sat with the Principal and NAAC Coordinator before penning down their final report. They discussed a few points for clarification with the Principal and the overall SWOC analysis was provided by the Chairman of PT in a sealed envelope to the Principal for opening after the declaration of the Grade by NAAC. The final day culminated with a cultural program organized by the students of the college depicting the cultural spectrum of Bengal that was highly appreciated by the peer team.

Subsequently, NAAC declared our college accredited with a grade of B++ (2.82 on a scale of 4).

35.05Reporting for consideration of IRG Plan

As per the directives of the Hon'ble Chairman, BOG in the last meeting, a perspective IRG plan was presented -

(A) IRG through Value-Added Certification Courses:

- (1) GPAT/JELET/D. Pharm Exit Exam Mock Test Series: Target group BCRCP and outside Pharmacy students (Proposed by Dr. Parthasarathi Panda, BCRCP)
- (2) Organic Spectroscopy Course: Target group BCRCP Pharmacy/Science Students (Proposed by Dr. Parthasarathi Panda, BCRCP)
- (3) Soft Skill Development & Professional Communication Skills: Target group -BCRCP and outside Pharmacy/Other stream students
- (4) AI based Certification Courses pertaining to the field of Pharmaceutical Sciences (to be conducted with the help of third party)

(B) IRG through Analysis of outside samples:

It is proposed that through the utilization of the advanced instruments at the disposal of the college (such as FTIR at Dr. A. K. Bandopadhyay Memorial Lab) / HPLC / Brookefield Viscometer DVIII+/ELISA Reader (at Central Instrumentation Room) / Digital Plethysmometer (Pharmacology PG Lab)), outside samples from neighbouring colleges may be analyzed at a cost to generate extra revenue. Target group was primarily M. Pharm / M. Sc. students of other Pharmacy/General PG colleges at the vicinity.

(C) IRG through Industrial Consultancy:

The faculty were being sensitized to take up Product Development / Method Development / Troubleshooting consultancy from Local industries. In this direction, already an Industrial Consultant (Mr. Subhendu Sinha Chowdhury, Member, Indian Pharmacopeial Commission) visited and interacted with the faculty and discussed the IRG avenues through Industrial Consultancy.

(D) IRG through Branded Practical Notebooks:

It was proposed to provide BCRCP branded notebooks for practical classes to students (starting new batch 2023) that would help in standardization of the lab notebooks and also extra revenue generation.

(E) <u>IRG through Selling FMCG Products via PMBJK</u>:

It was proposed that the PMBJK outlet might be utilized for selling certain FMCG products (such as White Phenyl) that could be manufactured at a low cost in the college itself.

Discussion and Resolution:

The Chairman, BOG asked to prepare a Detailed Project Report (DPR). He told to formulate both mandatory and willingness-based Certification Courses. To engage faculty members, additional payment would be necessary, said the Chairman. He also advised to prepare concept-based MCQs for evaluation of the certificate courses.

Plan on selling of Branded Notebooks and FMCG products were rejected by him.

The Chairman, BOG rather advised to explore possibility of Good Pharmacy Practice Training.

35.06Analysis of Students' Results in the Even Semester AY: 2021-2022

The complete result analysis of Even Semester UG, PG and Part I & II of Diploma Pharmacy examinations for AY 2021-22 was presented under **Annexure III**.

The UG and PG examinations were held in onlineproctored mode conducted by MAKAUT, WB while the Diploma Part I and II examinations were conducted by WBSCT&VE&SD through traditional pen & paper mode.

Discussion and Resolution:

Prof. Dipankar Sukul asked whether the college can compare its students' results with the same from other colleges.

Mr. Shobhan Bose, Asst. Prof. and In-Charge, Examinations expressed his inability as no such data was available.

35.07Report on Training & Placement Activities

The campus placement for the year 2022had ended, though the placement assistance would continue for the unplaced students. Several companies physically / virtually visited the campus that year, and till that date 29 companies either conducted interviews or hadcollected CVs for shortlisting candidates. For AY 2021-22 final year batch, total students placed till that date was 124 (62 UG + 27 PG + 14 Diploma) students through offline/virtual interviews/recommendations and 56 students hadtaken admission for higher studies both with the college as well as with other reputed national level institutions. The college was constantly updating the information for students who were being placed at various industries and Institutions as the hiring and admission process continued.

Like previous years, students were being encouraged to go for Industry/Hospital Training. After the post-pandemic slowdownthat severely impacted the training opportunity on siteinindustries, the scenario had improved that year and about 87 students of 3rd and 4th year B. Pharm students had already completed their industrial training at various companies and more were in the pipeline. Students were undergoing their training primarily from Sikkim / Baddi industrial belt, industries surrounding Kolkata and local hospitals. A few had also visited Baddi (Cipla) for training. Till that date 206 students from both 3rd and 4th year B. Pharm had completed their Hospital Training from various govt/private hospitals around the state and all 57 D. Pharm students had either completed or were on the verge of completion of Hospital Training (Part III Diploma). Diploma students became eligible for Registration as Pharmacists after their Part III training. Many companies asked for Registered Pharmacists for offering job; naturally, the placement scenario for D. Pharm pass outs would continue to evolve till all students get their registration. The detailed report was presented by the Placement Officer, Mr. Sanjay Chattaraj and the data was given in **Annexure - IV**.

Discussion and Resolution:

The Chairman, BOG commented on scarcity of IT related job and advised to take necessary measures to ensure best grooming and mentoring of the students.

35.08Report on the Faculty & Staff Strength and the Current Organization Structure

The strength of faculty stood at 42 full time and 04 part time teachers. In between 34th and 35thBOG meeting, fivefaculty hadjoined the collegeafter due process of advertisement, interview and selection committee recommendations and one laboratory assistant with requisite qualification had been promoted on leave vacancy to the post of Lecturer. Total number of Ph.D among the faculty stood at 20 then.

The total number of non-teaching staff including Laboratory Assistants stood at 31. Additional 22 conservancy staff was employed through third party agencies.
