
1. The In-charge of the Committee welcomes the Chairperson and other members of the house.

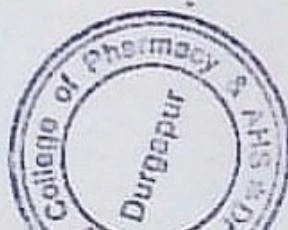
