

- Our students, Shreya Majhi, Sucheta Karmakar, Aniket Ojha and Mahima Chowdhury won the first prize in the 12th

Inter University Engineering, Science & Technology Academic Meet 2022 & Innovation model competition for sustainable society organized by Forum Of Scientists, Engineers And Technologists (FOSET) at Guru Nanak Institute of technology (GNIT) on the model titled 'Detecting Brain Tumor Using Artificial Intelligence'.

- The institute also helps students to prepare themselves for higher education through the institute run GPAT cell that helps them appear for the national level Graduate Level Pharmacy Aptitude Test (GPAT). In the year 2023, following students qualified the entrance examination; Nikita Dutta (AIR 222), Sourav Paul (AIR 1615), Somnath Singha (AIR 1871), Priya Ray (AIR 2152), Anurag Das (AIR 2257).
- Our faculty Dr. Aalok Basu is pursuing post-doctoral research at Mahidol University, Thailand.
- Our institute is actively involved in research activity which is reflected by the publication of scientific papers. Till date in 2023 a total of 54 publications in various reputed journals and 13 book chapters were made by faculty and students of the institute.



## DST-SERB FUNDED RESEARCH PROJECT

Dr. Yadu Nandan Dey, Associate Professor, BCRCP has received a prestigious Research Grant from DST-SERB, Govt. of India for the project entitled "Pharmacological Evaluation of purified roots of *P. zeylanica* roots in experimentally induced hemorrhoids" under the Start-up Research Grant Scheme, the research grant being Rs. 31.6

lakhs. As a Principal Investigator, Dr. Dey initiated the project and procured sophisticated instruments like a Cooling centrifuge, ELISA Reader, and Western Blotting equipment. Two Junior Research Fellows Arijit Nandi and Mousumi Paul and a Student Intern Sabhat Jamil were recruited under the project to conduct the research work. In the first year of completion of the project, the results of in-silico studies predicted the possible pathways of the anti-hemorrhoids action of the test drug. Further, the test drug was evaluated for 90 days of repeated dose sub-chronic oral toxicity study and anti-hemorrhoidal studies by Croton oil-induced hemorrhoids in rats. The bioactivity-guided fractionation and characterization of the fractions of the purified roots are ongoing. The financial support and the facilities developed through this project were also helpful for many M. Pharm and B. Pharm students to complete their thesis. The research findings were published in various reputed journals like Frontiers in Pharmacology, Journal of Biomolecular Structure and Dynamics, etc. Nandita Mandal, an M. Pharm student, received an award at International conferences for a poster presentation. Arijit Nandi got selected for his Ph.D studies at the Hebrew University of Jerusalem, Israel.



# INFRASTRUCTURE

The college provides state-of-the-art infrastructure support exceeding all PCI norms to all its students who are our greatest resource.

## CLASSROOMS

We provide well designed, well ventilated and well lit classrooms for enabling unhindered teaching and learning process with 'convenience' and 'care' as the key elements. These Class Rooms are Smart Class Rooms with Online Teaching and Lecture delivery facilities aided by Smart Boards and Projector Systems.



## LABORATORIES

BCRCP has twenty (20) well equipped spacious Departmental Laboratories for all the subjects of pharmaceutical sciences (Pharmaceutical Analysis, Pharmacognosy, Pharmaceutical Chemistry, Medicinal Chemistry, Pharmaceutics, Physiology, Pharmaceutical Engineering, Microbiology and Biotechnology, Pharmacy Practice and Pharmacology) as per the educational regulations laid down by PCI, New Delhi as well as MAKAUT, Kolkata. Experiments are designed on the basis of theory syllabi so that the students can understand concept easily.



Amongst these, BCRCP has dedicated PG laboratories and PG research laboratories for specialization in different M. Pharm courses with sophisticated instruments like Dissolution Apparatus, Lyophilizer with deep freezer, Tablet Punching Machine (Ten Station). Probe Sonicator, digital Plethysmograph, HPLC, Viscometer, UV Spectrophotometers etc. and provide an ambience to create industry-friendly learning environment and also to carry out M. Pharm projects smoothly and effectively.

Amongst these, BCRCP has dedicated PG laboratories and PG research laboratories for specialization in different M. Pharm courses with sophisticated instruments like Dissolution Apparatus, Lyophilizer with deep freezer, Tablet Punching Machine (Ten Station). Probe Sonicator, digital Plethysmograph, HPLC, Viscometer, UV Spectrophotometers etc. and provide an ambience to create industry-friendly learning environment and also to carry out M. Pharm projects smoothly and effectively.

## ANIMAL HOUSE

BCRCP has an excellent and well maintained CCSEA approved animal house that houses rats, mice & rabbit . Observation room with air conditioned facilities, documentation room etc are also present. Institutional Animal Ethics Committee has been formed as per CCSEA guidelines. The animal house is an added resource in the field of Pharmacology.

## MEDICINAL GARDEN

The institute has nurtured a good number of medicinal and aromatic plants in its well organized Medicinal Garden. These medicinal plants enthuse the students to identify them for demonstration as well as extraction of different kinds of drugs and also to generate an aptitude for research in Pharmacognosy and Phytochemistry. Each of our plant in the database has its own unique barcode (QR Code). These codes give students and visitor all the information they need to know about the tree-from and visitors its scientific name to its medicinal value.

## MUSEUM

A pharma museum with display of crude drug samples, photographs of medicinal plants, charts, proprietary medicines, containers, closures etc is established which is informative and educative and provides a glimpse of the pharmacy profession.



### RAIN WATER HARVESTING :

The college promotes water conservation through Rain Water Harvesting and channeling the extra water to subsoil through the harvesting pit.

**WASTE MANAGEMENT EFFORTS:** Every effort is made to reduce, reuse and recycle the waste generated throughout the campus. Waste management efforts include collection and segregation of different types of waste (solid, liquid, electronic, biomedical, etc.) and its scientific disposal.



### USE OF ALTERNATE SOURCES OF ENERGY:

The college adopts energy conservation practices such as use of LED bulbs & monitors, sensors and has setup solar energy generation facilities as an alternate source of energy.

### ACHARYA J. C. BOSE CENTRAL LIBRARY/RESOURCE CENTRE :

The Resource Centre of the college is the central library with collection of text books, reference books, Journals, Periodicals and CD ROM/DVD discs as well as e-learning facility. The library assumes a critical part in bestowing education. It is the asset center point and the resource hub for knowledge. At present library has vast collection of books in volumes 15650, Titles 1894, e-books 23922, e-journals 2358, print journals 34 (National and International). Library is fully automated using as the Codeachie Library Management System software is installed. OPAC computerized system is provided to the students which facilitates them to have a glance at the



number of books available, number of issued books, new books added to the collection which helps them to issue the correct book when required. Seating capacity of the library is around 100 with internet enabled six multi-media computers. BCRCP Library is the member of National Digital Library of India (NDLI), E-Sodh Sindhu, DELNET and Bentham publishers. Reprography and Document scanning facility is available in the library. The Library works on open access system from 10.00 a.m. to 5.30 p.m. daily except Saturday and Sunday.

### COMPUTER FACILITIES

The college started using computers from its very inception, both of in its academic and administrative activities. To cater to computing needs to all students and faculty for their professional activities, BCRCP provides state-of-the-art computer laboratory. There are modern state-of-the-art computer laboratories for the D. Pharm, B. Pharm & M. Pharm courses within the campus for the use of faculty students and research scholars. The large number of PCs are all connected to the high speed campus LAN. The campus LAN is connected to the Internet through 100-Mbps, 1:1 contention ratio. High quality laser printers, DMP printers, scanners and multimedia projectors are aslo available.

The B. Pharm computer laboratory is also designed to train the students in computer applications as well as to extend value added training on computer aided drug design and molecular modeling (CADD) Biostatistics and AI/ML. Computer based MOOCS are also provided through SWAYAM platform of GOI.

The college has a fully equipped seminar hall and auditorium to conduct in-house as well as national seminars and conferences, Tech Fests and other college events.

Centralized Instrument Room is present as an added facility to support experiments of various sorts carried out in the different laboratories. The center houses is HPLC, FTIR Spectrophotometers, Projection Microscope, Cooling Centrifuge, Trinocular Microscope, Elisa Reader and Washer, Recirculating Chiller, Brookfield Viscometer with small volume attachment, High precision imported pH meter, Eyela Rotavapour with Refrigerated cooling cum solvent recovery facility, Fluorimeter, Nepheloturbidimeter and Digital Plethysmometer etc. Handling such sophisticated instruments facilitate first-hand knowledge of high-level industry instruments.

**Machine Room** of the institute provides the facilities for pilot scale manufacturing of various pharmaceutical dosage forms, including tablets, semisolids etc.


# LEARNING SUPPORT

## SIMULATION LAB

A simulation laboratory is designed to provide immersive learning experiences for pharmacy students in the field of experimental pharmacology. The simulation laboratory consists of realistic looking physiological and pharmacological experiments, allow learners to practice and develop pharmacological expertise without any risk of animal harm. For practicing pharmacists, the professional standard requires participation in simulated practice each year to sharpen their bedside manner, as well as their pharmaceutical knowledge. It is equally important for pharmacy learners to partake in a similar simulated experience prior to working in real time.

The Simulation laboratory at Dr. B. C. Roy College of Pharmacy and Allied Health Sciences has been outfitted with latest version of online Ex-Pharm Series Software and that enables delivery of enough and essential training. Various areas of pharmacy and pharmacology. The laboratory is designed to provide undergraduate teachers of pharmacology and related subjects with access to a wide range of electronic resources for teaching. The simulation uses statistics based on data collected for real laboratory test results, and eliminates the need for using live animals. It provides resources from a range of simulations of laboratory experiments involving isolated tissue preparations and in vivo animal studies.

## IT CELL

In order to stay updated with the global advancements on advanced learning and research, an IT Cell has been created at the institute with specialized faculty members with the objective to teach students contemporary programming languages and to train them in subjects like machine learning, artificial intelligence and statistics with advanced tools and softwares. The IT cell will conduct various add-on courses for the undergraduate students that would span from 6 months to 1 year. One add-on course will focus on basics of Python programming and its implementations in database management, machine learning and artificial intelligence. ## DIPLOMA IN PHARMACY (D-PHARM)

The program has been designed to provide technical education and skill to enable the students to work competently as health care professionals in the industry, hospital and retail sector. The course will prepare a strong foundation for the candidates to work in the community and hospital sector where they play a very important role in efficient handling of medicines, inventory management, preparation of hospital formulary and assisting the physicians in patient care. Pursuance of the course will open up opportunities for studying B. Pharm via lateral entry in the 2nd year.

## BACHELOR OF PHARMACY (B-PHARM)

The programme has been designed to integrate the teaching of basic science along with the practice of pharmacy. The course emphasizes the importance of theoretical study, laboratory experiments and also of interdisciplinary communication and research. On the whole, it prepares a strong base for candidates who opt for industry as well a higher study and research programme in the study of pharmaceuticals.

## MASTER OF PHARMACY (M-PHARM)

M. Pharm is a future oriented specialization programme in the field of pharmacy. It is designed for successful B. Pharm candidates to develop advanced laboratory skills and techniques for application within the pharmaceutical industry as well as spearhead innovative research ideas for further development. In short, it is a gateway for better career and further higher studies to trigger constant up-gradation and rapid progress of pharmaceutical technology.

The four major specializations offering M. Pharm are :

- PHARMACEUTICS that deals primarily with extended study on drug dosage formulation, drug release pattern, kinetics study, bio-equivalence study their QA&QC and many more.
- PHARMACOLOGY that deals with therapeutic action and toxicology for existing and new drug candidate in the biological system.
- INDUSTRIAL PHARMACY that deals with studying all unit operations involved in draft from manufacturing, scale up, processing and development of drug delivery systems and dosage forms at the industrial level.
- PHARMACEUTICAL ANALYSIS that deals with the process for identification, purification determination and quantification and of a pharmaceutical substance, separation of the components of a solution or mixture, or determination of structure of chemical compounds for the pharma industry

## SOCIAL RESPONSIBILITY

The institute has an active National Service Scheme(NSS) Wing which has been highly active in carrying out social activities since many years and is recognized by the MAKAUT, West Bengal. # ADMISSION



## ADMISSION PROCEDURE FOR D. PHARM

The applicants have to qualify the Pharmacy entrance test (PET) conducted by WBSCT&VE&SD

### ELIGIBILITY CRITERIA

Candidate should have passed Higher Secondary (10+2) or its equivalent examination in General Stream Course with Physics, Chemistry & Biology or Mathematics. Candidates passed Higher Secondary (10+2) examination or equivalent examination in Vocational Stream Courses are not eligible for admission, as per prescribed admission eligibility of Pharmacy Council of India.

Candidate shall complete the age of 17 years on or

before 31st December of the year for admission to the Pharmacy Course.

## ADMISSION PROCEDURE FOR B. PHARM

The applicants will have to qualify West Bengal Joint Entrance (WBJEE) or JEE (Mains). 90% of the entrants are absorbed from the West Bengal Joint Entrance Examination (WBJEE) and 10% students are admitted from JEE(Mains) merit list. (10% of the total seats reserved for Management Quota)

### ELIGIBILITY CRITERIA

The applicant must be a citizen of India and should have passed the H.S. (10+2) or its equivalent examination from a recognized Council/Board with :

- Candidate must have passed '10+2' examination with Physics and Chemistry along with any one of Mathematics / Biotechnology / Biology / Computer Science /Computer Application as compulsory subjects with individual pass marks (in both theory and practical wherever applicable) in all the three subjects as stated above in regular class mode.
- Must have obtained at least 45% marks (40% in case of candidates belonging to reserved category) in the above three subjects taken together.
- Must have passed English in the '10+2' examination with at least 30% marks.
- The Board of the said Qualifying Examination must be recognized by the Central Government or State Government concerned.
- Candidate will have to qualify at the WBJEE or JEE (Mains) on the year of admission.

### LATERAL ENTRY

Admission through lateral entry to the 2nd year (3rd semester level) of the undergraduate degree courses offered by Government/Private Pharmacy colleges of the state of West Bengal during the Academic session 2021-22 is open to candidates who are -

- a) Citizens of India
- b) No upper age limit for Diploma holders in Pharmacy
- c) The candidate must pass Diploma in Pharmacy from PCI approved Institution with at least 45% (40% for SC/ST/OBC-A/OBC-B/PwD) marks or equivalent CGPA.
- d) Candidate should qualify JELET 2020.
- e) Should be able to produce Pharmacist Registration Certificate within one Month of Admission.

## ADMISSION PROCEDURE & ELIGIBILITY FOR M. PHARM

The applicant must be a citizen of India and should have passed B. Pharm with first Class Degree or Equivalent from any recognized University. GPAT qualified candidates will be given preference. Applicants will be selected through University Selection Test (PGET). Information Brochure and Application form can be downloaded from the University website ([www.makaut.ac.in](http://www.makaut.ac.in)). Candidates without valid GPAT score and PGET are also eligible to apply subject to availability of seats. They must produce Pharmacist Registration Certificate within one Month of Admission as per PCI directives. As per PCI requirement, for M. Pharm admission, 55% marks (50% for SC/ST) is needed in B. Pharm.

The date and time for the candidate to appear before the admission committee at Dr. B. C. Roy College of Pharmacy & AHS, Durgapur will be mentioned in the offer of admission or letter of call.

Only those candidates who appear before the admission committee on the date and time specified in the offer of admission or letter of call will bring the original documents as mentioned below and the fee for admission.

2. Admit card of WBJEE/JEE (Mains)/PGET/ Common Entrance Test for Diploma (original + two Xerox copies)
3. Mark-sheet of 10 and 10+2 examination (original + two Xerox copies)
4. 8 copies of stamp size coloured photograph
5. A recent certificate showing the powers of glasses for the candidates wearing glasses
6. Required amount of fee to be paid as fee for admission
7. Migration Certificate (Those who are already registered in any University other than MAKAUT, WB)
8. Registration Certificate (Original) for B.Pharm passout of MAKAUT, WB and two xerox copies.
9. Character Certificate from the head of the institution last attended
10. Allotment Letter of WBJEE/WBSCT & VE & SD for Centralized Counselling allotted candidate.
11. Aadhar card Original + Two xerox copies.
12. Photocopies of Pharmacists Registration Certificate (M. Pharm / B. Pharm. Lateral entry Applicants)
13. Domicile certificate is required at the time of admission.

## COLLEGE RULES AND REGULATIONS

### COLLEGE REGISTRATION

All the students will have to register their names at the beginning of each semester. Failure to do so will debar them from all facilities.

### ATTENDANCE

Each student is required to have at least 75% attendance in theory and practical classes; otherwise he/she will be debarred from appearing the semester examination (For B.Pharm & M.Pharm) under MAKAUT norms. (80% attendance for Diploma students is mandatory as per PCI norms)

### REMOVAL FROM COLLEGE ROLLS

The name of the students will be automatically removed from the college roll if:

1. he/she fails to pay up his/her dues in time
2. he/she remains absent from classes or hostel for more than 15 days without prior intimation
3. he/she, otherwise eligible, does not deposit any examination or admission form without prior permission from the Principal

### DISCONTINUATION OF STUDIES

In case a student opts for discontinuation of his/her studies in the stream he/she is enrolled, he/she will have to make payment of his/her due semester fees and only then, he/she will be issued transfer certificate. In case the student opts for joining other college, he/she must obtain NOC from the college giving a declaration that he

or she had no claim whatsoever subsequently on the said seat. In case he/she does not obtain NOC, all deposits will be forfeited.

### DISCIPLINE

All students must abide by the rules and standing orders of the college, violation of which or any misconduct inside or outside the college campus may lead to disciplinary action as per the regulations and render a student liable to expulsion from the college. Students have to sign an undertaking to this effect for the above during admission. Further, if as a result of any demonstration or strike, any college property is damaged, the cost will be covered directly from the students who are identified or collectively from such group of students who are responsible for it. In case of non-identification of any student(s) mass fine shall be imposed thereon.

### GRIEVANCE REDRESSAL COMMITTEE (GRC)

The College has a well defined Online Grievance Redressal Mechanism through a duly constituted Committee for all stakeholders.

### ANTI-RAGGING MEASURES

The College ensures Ragging Free environment for healthy and holistic learning. Anti-Ragging banners and Hoardings are displayed at prominent places in the campus and Anti-Ragging Squads keep constant vigil. Awareness among all stake holders regarding Anti-Ragging measures are constantly disseminated.

### INTERNAL COMPLAINTS COMMITTEE (ICC)

As per the sexual harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013, our Institute has an ICC for considering complaints for sexual harassments of women working and studying in the Institute. The complaint can be made either in paper form or through My Grievance in the Institute web page <https://bcrcp.net/login.php>. As per Act, aggrieved woman can make written complaint of sexual harassment at workplace to the ICC within a period of three months from the date of incident and in case of a series of incidents, within a period of three months from the date of last incident.; while in case the aggrieved woman is unable to make a complaint on account of her physical incapacity, a complaint may be filed inter alia by her relative or friend or her co-worker or any person who has knowledge of the incident, with the written consent of the aggrieved woman complaints of sexual harassment of women employees and girl students. Once a complaint is submitted, it will be directly sent to the Internal Complaint Committee (ICC) and subsequent actions are taken. The major functions of the Internal Complaints Committee involve implementing the Policy relating to the prevention of sexual harassment, resolving complaints by the aggrieved and recommending actions to be taken by the employer.

**GENDER EQUALITY:** The institute, being a co-educational college has gender-neutral policies that ensure promotion of gender equality in various areas of operation. Special drives are taken to sensitize the students to spread awareness regarding gender issues for preventing any kind of discrimination whatsoever through Women's Empowerment programs, Internal Complaints Committee (ICC) following the SAKSHAM guidelines, Anti-Discrimination Cell, Grievance Redressal Committee, Code of Conduct and Disciplinary Committee. For the safety and security of all students, the campus and buildings are under constant CCTV surveillance, security guards are posted at the gates and in front of Girls' Hostel, all buildings are provided with Fire-Extinguishers and an automated fire-alarm with all associated fire-fighting equipments are installed in the campus.
